
Only 22 years of age, Elaine is an inquisitive individual, and she aspires to continue her studies in Corporate Finance and Law.

The following week, on 25<sup>th</sup> October 2021, we had the pleasure of hosting PKF International. The visit was attended by the CEO of PKF International, Mr. Theo Vermaak, and was part of the scoping process for the PKF Africa Conference that will be held in 2022.

On 1st November 2021, Trois Freres Distilleries Limited ("TAKA") issued a private placement of up to 500,000 shares. Shares were allotted in terms of the published allotment table.
