HRMC Recognition of Listed Debt on MERJ Exchange

As of 28 September 2020, the Debt Market of MERJ Exchange Limited ("MERJ Exchange") has been recognised as meeting Her Majesty's Revenue and Customs ("HMRC") definition of 'listed' for the purposes of HMRC legislation.

Therefore, UK source interest on debt listed on MERJ Exchange should be exempt from the requirement to withhold tax by UK companies, or partnerships of which a UK company is a member.

As a result of this recognition, a wonderful opportunity arises for UK Corporates to issue debt at a much lower cost if done so through MERJ Exchange. It also creates the opportunity for retail investors to invest using self-invested personal pensions ("SIPP's") and/ or individual savings accounts.

PKF has already listed their first debt listing (PKF PCC Class 1) on 16 September 2020 and anticipates listing their next program during Q2 of 2021.

Successful Listing of 13 Peaks Marathon: Solid Oak Insurance **PCC** Limited



On 14 December 2020, PKF successfully listed Solid Oak Insurance PCC Limited ("SOL") on MERJ Exchange.

SOL was registered on 16 May 2016 in the Republic of Seychelles under the Seychelles Companies Ordinance, 1972. The Company markets two products, being its single flexible long-term insurance policy capable of holding both liquid and illiquid investments in an offshore environment that is efficient from both a tax and estate duty perspective, as well as a single premium annuity policy marketed to high net-worth individuals in Canada.

SOL is a Non-Domestic Long-Term Insurance Company (License no: NDI011), licensed by the Financial Services Authority of Seychelles ("FSA"), to carry on linked long-term insurance business in accordance with Section 10(1) of the Insurance Act, 2008. This certificate was issued on 6 July 2016 and the Company was granted permission to begin operating on 8 September 2016.

The Company is a Protected Cell Company ("PCC") which comprises the core and one cell. The purpose of the cell is to hold policy assets and the cell does not generate income or incur expenses.

PKF's Justin Porteous overcomes gruelling challenge.

Justin Porteous, Investment Manager at PKF recently finished a 106km marathon in Cape Town, South Africa under extreme conditions. He writes about his phenomenal achievement below:

"When one of the world's best ultramarathon trail runners set a route traversing his "best" mountain peaks in and around his hometown, it tends to catch the attention of every "aspiring" athlete in the area. However, it takes a while (in my case 15 hours into the adventure) to realize that when one of the world's best athletes sets a route on his local turf it will most definitely be a gruelling challenge.


Eight of us over eager men – all amped up from 8 weeks of banter and braais, where different nutrition strategies and meticulous route plans were discussed - set out for the 106km route with over 6400m total altitude gain



We set out early on a Thursday morning on a still and warm summers day with high spirits and strong legs. The route starts with the fun Lions Head peak, full of hikers to cheer us on and lift our spirits even higher. Then the work starts with the hike up Table Mountain, the sunrise already pushing the temperature towards 30°C. By the first "wife aided water stop" we had been out for close to 7 hours over two mountains, ticked off 5 of the peaks but only done 27km. The heat had already started to take its toll and over the next 10km's we had lost 4 members and were down to 4 heading towards the iconic Chapmans peak.

The heat had been well above 30°C since 7am and finally dropped below when we broke the back of the day traversing Noordhoek peak at around 7pm – 50km in the bag. Arriving at the next "wife and fallen soldier" manned waterpoint we were tired, sore, and hungry with motivation levels at a real low. As we got closer, we heard music and smelt food and to our delight around the corner we saw a small party of excited cheers which fuelled us on to the next peak.

Within 100m we could no longer hear the music or cheers and now we were alone in the dark and heading back into the mountain. The next 4 hours were mainly a blur before arriving at our final waterpoint – or pizza point at 2am. The welcoming party was down to a few hardcore (willing to come and help us survive). At this point we lost another soldier to strained knees which left 3 of us for the last 2 peaks.

With bellies filled, we felt good and the still calm and warm night above Constantia was surreal. All we could hear was a distant peacock as we climbed towards the penultimate peak with 20km looming before the finish.

Between peaks 12 and 13 we descended towards Kirstenbosch and along the Newlands contour which made me feel like Bilbo Baggins walking through the stifling Mirkwood forest, especially with the odd spider web wrapping around your face. Once through this section it was the final climb – aptly named Devils Peak. Here we had pumping wind and rain which made us feel even more hardcore as we reached the top. Mustering up a smile for a selfie we then headed home to Signal hill.



After 30 hours of both fun and pain we managed to finish arguably one of the most scenically stunning runs in the world and likewise one of the toughest events we have ever done."
